Sheltered Point-in-Time Count (PIT)

Each year, HUD requires Continuums of Care (CoC) to report local information about homeless persons through the Homelessness Data Exchange (HDX). CoCs must conduct an annual point-in-time count of sheltered homeless people. Unsheltered counts are required at least once every two years, with odd calendar years being required years. All PIT counts must be conducted during the last ten calendar days in January — between January 22nd and 31st.

Due to the pandemic and putting health and safety above all else, the Regional Taskforce on the Homeless (RTFH) and its board of directors decided not to conduct its annual Point-in-Time Count (PITC) of unsheltered San Diegans for 2021. The region's CoC applied for and was granted an exception by the Department of Housing and Urban Development (HUD) for the year.

Sheltered: Housing Inventory Count (HIC)

The HIC report provides a snapshot of the CoC's capacity to provide housing to people experiencing homelessness. It collects information about all the beds and units available on a designated night at the end of January by program type. The count includes temporary shelter (emergency shelter and transitional housing) and permanent housing (rapid rehousing and permanent supportive housing.)

This chart provides an overview of changes in the number of total beds/units for homelessness-dedicated housing interventions such as Emergency Shelter (ES), Rapid Re-Housing (RRH), Transitional Housing (TH), and Permanent Supportive Housing (PSH) from 2018-2021.



Utilization Rates the Night of the Count



Utilization rates are based on the total number of beds available in San Diego County and the percentage of those beds that are in use the night of the Point-in-Time Count. The percentages below show a snap shot of how effectively shelter programs are matching people with beds on any given night.
