FY 2022 Continuum of Care (CoC)
Notice of Funding Opportunity (NOFO) Preliminary Results**

The U.S. Department of Housing and Urban Development (HUD) requires the Collaborative Applicant for the Continuum of Care (CoC) to provide a series of public notices during the annual CoC NOFO Competition.

The Regional Task Force on Homelessness (RTFH) and the Continuum of Care (CoC) Board established a Rating and Ranking Group to review, score, and rank project applications requesting funds under this competition.
