

2025 Point-in-Time Count Data

Since 2017, RTFH has partnered with the San Diego County Sheriff's Office to conduct surveys of incarcerated persons as part of the Point-in-Time Count. In 2025, seven jails participated. On the night of the count in January, 3,956 persons were incarcerated, and 1,009 persons (26%) were asked to participate in the count. Of those surveyed, **37**%, totaling 376 persons, reported experiencing unsheltered homelessness prior to their arrest.







Key Findings

- The percentage of incarcerated persons who reported experiencing unsheltered homelessness before their arrest increased from 36% in 2024 to 37% in 2025, a 1% increase.
- 40% of surveyed persons who were unsheltered said it was their first experience of homelessness, down from 52% in 2024 (a 12% decrease).
- 20% of unsheltered persons reported living in a vehicle the night of their arrest, a slight increase from 19% in 2024.
- 41% of unsheltered persons had a history of juvenile detention, down from 43% in 2024.
- 84% of unsheltered persons had been previously incarcerated in jail or prison, a decrease from 89% in 2024 (a 5 % drop).
- 24% of those unsheltered before arrest said they left permanent housing due to safety concerns or violence, up slightly from 23% in 2024.
