April 2026	April 1, 2026	FY 2026 CoC Program registration opened in e-snaps. The April 23, 2026, 5 p.m. ET deadline was met by RTFH.
	April 14, 2026	RTFH notified CoC grantees of the APR data performance evaluation for the FY 2026 competition. The evaluation period was May 1, 2025, through April 30, 2026.
May 2026	May 1, 2026	Program APRs were pulled for CoC-funded programs with reportable data from May 1, 2025, through April 30, 2026.
	May 20, 2026	RTFH held two in-person listening sessions for existing CoC grantees and CoC Board members.
	May 21, 2026	RTFH requested preliminary Intent to Submit and CoC Applicant Registration via the CoC listserv and website, due May 27 at 5 p.m.
	May 21, 2026	HUD released final FY 2025 CoC awards for third- and fourth-quarter grantees, confirming projects eligible for renewal.
June 2026	June 1, 2026	HUD released the FY 2026 CoC Competition and YHDP Grants NOFO.
	June 2, 2026	RTFH posted a public notice announcing the FY 2026 NOFO and local timeline.
	June 5, 2026	RTFH posted a public notice about NOFO priorities and local highlights.
	June 5, 2026	RTFH called for FY 2026 CoC Applicant Registration and Intent to Submit, due June 15 at 5 p.m. via Google Forms.
	June 11, 2026	CoC General Membership meeting: FY 2026 CoC NOFO overview.
	June 15, 2026	RTFH called for renewal applications and new project proposals, including local submission requirements.
	June 18, 2026	San Diego CoC Board approved the CoC Program Evaluation Methodology, CoC priorities, and Reallocation Policy.

July 2026	July 13, 2026	Local deadline for all CoC project applications and required documentation.
	July 15, 2026	RTFH requested signed certifications of consistency with the Consolidated Plan from local jurisdictions.
August 2026	August 5, 2026	Original schedule for notifying applicants of acceptance, rejection, or reduction and posting the preliminary rank order.
	August 5–10, 2026	Local appeals period and Rating and Ranking Committee review. Appeals due August 10 at noon.
	August 10, 2026	Original deadline for local jurisdictions to submit signed certifications of consistency with the Consolidated Plan.
	August 10, 2026	RTFH sent a public notice through the CoC listserv stating that the FY 2026 CoC NOFO was paused following a court order.
September 2026	September 18, 2026	HUD reopened the FY 2026 CoC NOFO to accept applications and set a new deadline of September 30, 2026, at 8 p.m. ET.
	September 22, 2026	RTFH publicly posts the final priority List on the RTFH website
	September 30, 2026	Deadline for CoCs other than CA-600 to submit their FY 2026 Collaborative Application and Priority Listing: 8 p.m. ET (5 p.m. Pacific time). HUD extended CA-600's deadline to October 14, 2026.
	September 30, 2026	RTFH will publicly post the CoC Collaborative Application and Priority Listing by the HUD submission deadline (Can be found on the CoC's NOFO page).
