PROJECT – LEVEL APPLICATION AND SUBMISSION INFORMATION

The Special CoC Unsheltered NOFO requires the local Continuum of Care (CoC) to review, score and rank-order all project applications requesting funds under this opportunity.

HUD requires the CoC to evaluate each application using objective data in several areas:

- Applicant and Project Eligibility Threshold Criteria
- Statutory and Regulatory Criteria
- Organizational Capacity and Performance
- Project Quality Criteria
- Responsiveness to the CoC Plan
- Project Design
- Fiscal Management and Cost Effectiveness

EVALUATION of PROJECT-LEVEL APPLICATIONS

Eligibility Threshold Criteria

In order to be considered for funding, Project Applicants and potential subrecipients must meet the eligibility requirements of the CoC Program (24 CFR part 578) and provide evidence of eligibility required in the application. The project cannot be funded if these basic criteria are not met.

Applicant Eligibility Threshold Criteria

Each applicant organization and subrecipient organizations must:

- Be a legal entity eligible to receive funds (e.g. 501-c3, unit of government, recognized Tribal entity);
- Have an active System of Award Management (SAMs) account, the SAMs registration will
 need to be current through the initial project award by HUD. Applicants with expiration dates
 prior to the end of January, 2023 will need to renew their registration in order to remain
 eligible;
- Provide their organizational Unique Entity Identifier (UEI);
- Meet Statutory and Regulatory Requirements in 24 CFR part 578;
- Agree to comply with a series of Federal Assurances and Policy Requirements 1;
- Not have delinquent outstanding Federal debt;
- Not be debarred or suspended from doing business with the Federal government (any department);
- Have filed ethical standards/Code of Conduct compliant with 2CFR part 200 with HUD, or include a copy in the Applicant Profile section of the *E-snaps* application packet;
- Not have outstanding Civil Rights, Fair Housing, or determination of findings for cause, or charges;

- Demonstrated sufficient fiscal organization and management capacity to effectively administer federal funds to carry out the project;
- Meet HUD standard described on 17-19 of the Unsheltered NOFO;
- A full checklist of Applicant Eligibility criteria is included in the Rating and Ranking Tool
- To be eligible for funds, the Applicant and Project must also meet Quality

Project Eligibility Threshold Criteria

HUD reviews all projects to determine if they meet the following eligibility threshold requirements on a pass/fail basis. If HUD determines that the applicable standards are not met for a project, the project will be rejected.

- Participate in the approved CoC Homeless Management of Information System (HMIS), or in the comparable Data System for Domestic Violence providers identified by the CoC;
- Demonstrate operational integrity with the Housing First model of project implementation;
- Propose to serve eligible participants, defined as homeless under paragraph 1 or 4 of the HUD definition of homelessness, and as described in Section II.B. 4 of the NOFO;
- Demonstrate Fiscal Management and Cost Effectiveness Capacity;
- Provide a Certificate of Consistency with the local Consolidated Plan
- Propose only activities identified as eligible in the NOFO. See additional information in the Project Threshold Section.
 - o CoC Planning Projects: Maximum of 3%
 - o Permanent Supportive Housing (PSH)
 - o Rapid-rehousing (RRH)
 - o Joint Transitional and Rapid Rehousing (TH- PH-RRH)
 - o Supportive Services Only CE
 - o Supportive Services Only Other (see additional information in the Project Quality Threshold chart and Responsiveness to the CoC Plan sections below)
 - o HMIS
 - o Awards are to be used over a 3-year grant term
 - o Note: Projects requesting acquisition, rehabilitation, or new construction funds will be rejected by HUD.

Project Evaluation - Past Performance

Although all projects proposed in the Unsheltered NOFO must be new, HUD will consider a project applicant's past performance when evaluating the project proposal. These items should be reflected in the local project review process.

HUD's review includes but is not limited to:

- the ability to account for funds in compliance with applicable reporting and recordkeeping requirements
- timely use of funds received from HUD (project startup, a minimum of quarterly drawdowns), full expenditure of fund
- timely submission and quality of reports submitted to HUD;
- meeting program requirements
- meeting performance targets as established in the grant agreement

- the project applicant's organizational capacity, including staffing structures and capabilities
- timely completion of activities and receipt and expenditure of promised matching funds
- the number of persons served or targeted for assistance
- promoting self-sufficiency and economic independence
- producing positive outcomes and results

HUD may reduce scores based on the past performance review. Wherever possible, HUD will obtain past performance information and if this review results in an adverse funding related to integrity of performance, HUD reserves the right to take any of the remedies necessary.

Project Quality Threshold

In addition to project administration and management factors, HUD considers project quality and past performance outcomes. HUD reviews all project applications to determine if they meet the project quality threshold requirements. If awarded, a recipient is required to meet all the criteria listed in the criteria column for its component. Additionally, the housing and services proposed must be appropriate to the needs of the program participants and the community.

Project Quality Assessment Capacity, Timeliness, and Performance Standards.

To be considered as meeting project quality threshold, all projects must meet all the criteria listed below. These items should be included in our work plan.

- (1) Project applicants and potential subrecipients must have satisfactory capacity, drawdowns, and performance for existing grant(s)
- (2) Timely reimbursement of subrecipients, regular drawdowns, and timely resolution of any monitoring findings
- (3) Project applicants must demonstrate they will be able to meet all timeliness standards per 24 CFR 578.85.

HUD reserves the right to reduce or reject a project application from the project applicant for the reasons listed below. These would be addressed in HUD monitoring reports and should be included in the project review:

- (a) outstanding obligation to HUD in arrears or no payment schedule
- (b) audit finding(s) for which a response is overdue or unsatisfactory
- (c) history of inadequate financial management accounting practices
- (d) evidence of untimely expenditures on prior award
- (e) history of other major capacity issues that have significantly affected the operation of the project and its performance
- (f) history of not reimbursing subrecipients for eligible costs in a timely manner, or at least quarterly
- (g) history of serving ineligible program participants, expending funds on ineligible costs, or failing to expend funds within statutorily established timeframes.

II. Responsiveness to the CoC Plan

The Unsheltered NOFO centers on persons with severe service needs and leverages housing and

health care resources outside the CoC and ESG programs.

<u>Projects for Supportive Services Only – Other must be able to identify they will be able to obtain and maintain permanent housing for persons with the highest service needs.</u>

SSO- Other project should clearly link supportive services to secured permanent housing opportunities (such as PSH, RRH, or PH-Other) or detailed strategies for obtaining a sufficient number of housing opportunities for the number of participants proposed in the project.

In addition to the factors discussed above, Project Review points should assess and express in measurable terms:

III. Project Specific Requirements and Commitments

To be included in the Unsheltered NOFO application to HUD, all projects must commit to, and subsequently implement:

- A barrier, Housing First approach;
- Use of Homeless Management of Information System (HMIS), or the approved alternate data base for Victim Service Providers for record keeping and client tracking;
- Participation in the approved Coordinated Entry System (CES);
- A Commitment to Further Equity for over-represented, under-served, and vulnerable groups: racially or ethnically diverse; alternate gender identity including LGBTQIA+; persons with disability; and
- Any commitment included as part of the project application (including but not limited to those on the New Applicant Threshold Checklist, the applicant assurances contained in *E-snaps*, match and leverage amounts).

IV. E-Snaps Application Notes

Projects requesting Consolidation, Renewal Expansion, Transition, or funding for Acquisition, Rehabilitation, and New Construction will be rejected.
