U.S. Department of Housing and Urban Development (HUD) 2022 Continuum of Care (COC)Youth Project

OVERVIEW

HUD renewed the CoC Y (YHDP) funding to RTFH for one year to continue the work of ending youth homelessness. RTFH renewed all previously awarded projects – awarding 18 subrecipient agreements to eight providers totaling \$3,713,298. The grant term for these projects extends from December 1, 2023 through November 30, 2024 .Affirming the community-wide commitment outlined in the <u>San</u> <u>Diego County Coordinated Community Plan to End Youth Homelessness (CCP)</u>,

FUNDING AWARDED

The 2022 CoC Y funding for the San Diego Region includes:

- \$167,582.00 in Host Homes Project;
- \$630,000.00 in Prevention and Diversion Project;
- \$650,000.00 in Youth Service Navigator Project;
- \$164,949.00 in Rapid Re-housing Project;
- \$2,100,767.00 in Joint TH-RRH Project; and
- \$166,030 in Administration.

MATCHING FUNDS

All projects must provide a 25% match for all HUD funds requested, except leasing funds.

- If the awarded amount is the same as the 2021 CoC Y Agreement, the subrecipient will submit the match letter that was provided in the 2022 HUD NOFO.
- If the award amount has changed, applicants must submit an updated signed match letter of commitment.

Match letters must be uploaded to the assigned folder in Dropbox by, Friday, October 6, 2023.

Dropbox Documentation Labeling

RTFH will email each subrecipient a link to their assigned folder in Dropbox.

The subrecipient will upload the required documentation into their assigned Dropbox folder using the following naming convention:

AgencyName_2022_Document Name

The document name is **<u>bolded</u>** and **<u>underlined</u>** in the project checklist above.
